Irvine and Bell Family Papers

Biographical Note:

Mathew Bell (29 June 1769 – 24 June 1849) was a politician, businessman, soldier, politician, and seigneur. Born in Berwick-Upon-Tweed he immigrated to Quebec when he was 15. He cofounded Monro and Bell, a successful import-export business, which also ran the Saint-Maurice Ironworks from 1800-1845. His daughter Anne married John George Irvine.

John George Irvine (1802-1871) was a Lieutenant Colonel as well as being Aid du Camp to the Governor General of Canada.

George Irvine (16 Nov. 1826 – 24 Feb. 1897) was the son of John George Irvine and was a lawyer, judge, professor, and politician. He represented Mégantic in the Legislative Assembly of Quebec from 1867-1876 and as a Member of Parliament from 1867-1872. He married Annie Routh LeMesurier, daughter of Henry LeMesurier.

Mathew Bell Irvine (1832-1899) was the son of John George Irvine and served as Commissary General of the British Army.

Acheson Irvine (7 Dec. 1837 – 8 Jan. 1916) was the son of John George Irvine who served as Commissioner of the North-West Mounted Police from 1 Nov. 1880 – 31 Mar. 1886 and was involved in the events of the North-West Rebellion (or North-West -Resistance).

Henry LeMesurier (17 Nov. 1791 – 25 May 1861) was a soldier and businessman born on the island of Guernsey. He came to Canada during the War of 1812 and after the war became an important businessman in Quebec and was involved in the founding several resource and transit related firms. He was also Deputy Master of Trinity House, and Master from 1846-1861, working with the movement of ships along the St. Lawrence and with upkeep of lighthouses.
