

This collection contains papers and other documents pertaining to the work of Jack Batten, a Toronto-based writer and journalist. Born in Montreal in 1932, Batten practiced law from 1959 to 1963 before turning his full attention to writing. He is the author of over thirty books and hundreds of magazine and newspaper articles.

Includes early draft, edited MS, and galley versions of *The Inside Story of Conn Smythe's Hockey Dynasty* (1969), *The Honest Ed Story* (1972), *The Leafs in Autumn* (1975) *Canada Moves Westward* (1977), *Lawyers* (1980), *In Court* (1982), *Robinette: The Dean of Canadian Lawyers* (1984), *Tie-Breaker* (1984), *The Appleby Story* (1985), *UTS: 75 Years of Excellence* (1985), *Judges* (1986), *Crang Plays the Ace* (1987), *Everyday Law* (1987), *A Short History of Crescent School* (1987), *On Trial* (1988), *Straight, No Chaser* (1989), *Riviera Blues* (1990), *Blood Count* (1991), *The Class of '75* (1992), *The Spirit of the Regiment* (1992), *Rosedale: The First 100 Years of the Rosedale Golf Club* (1993), *The Leafs: An Anecdotal History* (1994), *Mind Over Murder* (1995), *Hoopla: Inside the Raptor's First Season* (1996), *A History of Bennett Jones Verchere* (1997), *Big Bay Point* (1999), and other texts. Collection also includes notes, reviews, printed ephemera, publicity tour information, general and financial correspondence, diagrams, photographs, and research and other materials, much of which relates to specific works.

Correspondence includes letters to and from personalities like journalists Robert Fulford, Peter Gzowski, and Michele Landsberg; publisher Jack McClelland; politician John Sewell; hockey pioneer Conn Smythe; and musicians Gary Burton, Blossom Dearie, and Phil Nimmons.

Folder descriptions, where possible, are taken directly from titles given by Batten to his own folders. Shorthand notations are used throughout the finding aid and are to be translated as follows: MS – manuscript; H – holograph text; WP – word processed text; ER – editorial revision; HR – holograph revision.
