## **The Champlain Society Papers, 2017**

**Dates:** 1905-2012 (bulk 1970-2012)

**Extent:** 49 boxes (9.25 metres)

### **Biographical Description:**

Founded in 1905, The Champlain Society works to echo the voices of some of Canada's most eloquent citizens. Since the early 1600s, explorers, merchants, public servants, scientists, ordinary people, and extraordinary men and women have left riveting accounts of their actions and thoughts. Through its books and Digital Collection, its blog and its podcasts, the Champlain Society makes the adventures, explorations, discoveries, and opinions that have shaped Canada available to all who have an interest in its past. The Champlain Society is accessible, but it is uncompromisingly scholarly: its works are the object of meticulous treatment by specialists whose role has been to highlight the significance of the eyewitness accounts and to inform readers of the context in which these documents were drafted. The mission of The Champlain Society is to increase public awareness of, and accessibility to, Canada's rich store of historical records. For more than 110 years, the Champlain Society has increased public access to Canada's rich documentary heritage. It aims to help Canadians explore four centuries of adventure, travel, social change, economic growth, and nation building through the Society's books and online Digital Collection.

### **Scope and Content:**

This latest deposit of the Champlain Society's papers includes financials, including invoices, balance sheets, account receivable reports, financial reports, donations and fundraising, banking and tax returns. Also included are council minutes and reports from 1979 to 2009, as well as list of council members and officers. Administration files relating the running of the Champlain Society include reports on their history, the Chalmers Awards submissions, membership, correspondence, marketing material and permissions. This deposit contains extensive material on the publications of the Champlain Society from both the Ontario Series and the General Series, most notably *The Eldon House Diaries: Five Women's Views of the 19<sup>th</sup> Century*, *The Writings of David Thompson* and *The Life and Times of Samuel de Champlain: Des Sauvages and Other*

*Documents Related to the Period Before 1604.* This includes proofs, drafts, illustrations, correspondence and contracts with both volume editors and publishers.
